- Write your roll number on the front of the cheque.
- Cheques can be mailed, dropped off or paid in person at office. The outside drop box is open 24/7.

Payments are recorded on the date it is received not the date it is mailed.


2025 Budget Highlights

Each year, our Council develops a budget that funds strategic initiatives and capital projects that sustain services and service levels for Ramara Township. The 2025 budget outlines investments in capital planning and infrastructure, including road maintenance and water and wastewater upgrades. On November 25, Council adopted the 2025 budget with a 5.14% increase on the municipal portion of the 2025 tax rate.

2025 Operating and Capital Expenses

Municipalities are service based organizations and provide a wide variety of services. The challenge is striving to meet the needs of as many of our residents as possible in a fiscally responsible way. In the 2025 Budget, the total expense budget is approximately \$35.7 million.

For 2025, OPP expenses increased by 23%, constituting 2.6% of the tax rate increase.



Property Assessments

In Ontario, property assessments are determined by MPAC and then shared with the Township of Ramara. Your property assessment and property taxes are not the same thing. Ramara uses your property assessment to determine the revenue requirements, set municipal tax rates and collect property taxes to pay for municipal services. 2025 Dog Tag

Be sure to purchase your 2025 dog tag before it's too late! Dog tags (licenses) can be renewed online, in person, or by mail.
